- Guideline for these activities will follow the policies and procedures which govern such arrangement at each institution.

Article 3

The financial support for the collaboration proposed in Article 2, will be sought from Central India Fire and Safety Research Centre and/or private and national organization of both sides.

Article 4

This memorandum of Understanding shall become effective from the date of its signing by the representative of both institutions shall remain in effect for five (5) years and can be extended by the written mutual consent. Either side may terminate this agreement at any time by giving a written notice of THREE (03) months advance to other institution.
