MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on this 2nd March 2024 by and between

Organo Mushroom,55, Kulswamini, Tukdoji Society Prabhu Nagar, Manish Nagar, Somalwada Nagpur 440005 and represented herein by its Director, Ms. Priya Bavaskar, which expression shall mean and include its successors in office and assigns.



WHERE AS:

- A) First Party is a Higher Educational Institution named:
 - Shivaji Education Society Amravati's Science College, Congress Nagar, Nagpur
- B) First Party and Second Party believe that collaboration and co-operation between themselves will promote more effective use of their resources and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Technical/Management Education and Research.
- D) Both Parties being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) Organo Mushroomthe Second Party is engaged in Business, Skill Development, Education and R&D Services in the fields of Hardware studies and related fields.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interest and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution**. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements and documents as may be required to give effect to the actions contemplated in terms of this MOU.

CLAUSE 2 SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in technological upgradation, innovation and competitiveness of an industry. Both Parties believe that close co-operation between the two would be of major benefit to the students community to enhance their skills and knowledge.
- 2.2 **Curriculum Enrichment:** Second Party will give valuable inputs to the First Party in teaching/ training methodologies and suitable customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 Industrial Training, Internship, Live Projects Visits: Industry and Institution interaction will give an insight in to the latest developments / requirements of the

industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs, internshipand Live Projects for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs/ Workshops/ Industrial Sites for the hands on training of the learners enrolled with the First Party. First Party to train the industry person of Second Party for imparting training as per the industrial requirement.

- 2.4 Lab Designing: Industry based Laboratories sponsored by industries at the Institute.
- 2.5 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.6 Guest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.7 Faculty Development Program: Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 Placement of Trained Students: Second Party will actively engage to help the delivery of the training and placement for the students.
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Program on the terms specified herein.
- 2.10 There is no financial commitment on the part of the **Shivaji Science College**, **Nagpur** and the First Party to take up any program mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3

VALIDITY

- 3.1 This agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during period **Organo Mushroom**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Organo Mushroom**, the Second Party after termination of this Agreement by way communication, correspondence etc. shall not be constructed as an extension of this MOU.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days notice in writing in the event of Termination; both parties have to discharge their obligations.

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
