## Item 7. Discussion on appointments of teaching staff for PG Courses (Non-grant)

Hon'ble Principal informed the house that as per letter dated 21/12/2018 of RTM Nagpur University, Nagpur, it is necessary to make appointment of at least one teachers in each subject of the PG Courses (Non-grant). He further informed that the college has initiated the process and sought No objection certificate from university vide its letter dated 27/12/2018 and approval of roster is in process.

IQAC discussed the matter and Hon'ble President directed the Principal to take follow up action so that appointments for the said courses can be made as soon as possible.

Item 8. Discussion on submission of proposal seeking permission to start new subjects/ programme / Certificate courses

Hon'ble Principal proposed to start the following certificate courses which are skilled base.

Wild life conservation (2) Mushroom Cultivation (3) Bio-fertilizer and Bio-pesticide
(4) Bio-degradable soil waste management (5) Water Management

He also informed that the process has been already initiated to start these courses.

IQAC discussed the matter and approved the same.

Item 9. Discussion on plan of action of various department and outcomes for the current session 2018-19

The college has to submit proposal along with fee of Rs. 30,000/- for the same.

Item 12. Discussion on new guidelines published by NAAC

IQAC Coordinator put forth for discussion the essential Metrics for UG and PG of affiliated College for NAAC accreditation as per revised guidelines of NAAC, July, 2017.

IQAC discussed the matter.

Hon'ble president suggested to undergo quality assurance initiatives and to partcipate in National Institutional Ranking Framework (NIRF).

Hon'ble Principal suggested that every teachers should published at least one research papers in UGC approved Journals in every year. He also encouraged to published books/chapter in books, research papers in National/ international conference proceedings.

Hon'ble Principal encouraged the teachers to participate in professional development programmes viz., Orientation Programme, Refresher Course, Short Term Course, Faculty Development Programme etc.

IQAC Coordinator suggested for strengthening the capability enhancement and development schemes viz., Competitive Examinations, Career Counseling, Soft Skill Development, Remedial Coaching, Language Lab, Bridge Courses, Personal Counseling and Yoga and Meditation. Concerning Criteria –wise convener and Convener of the committee should take initiative for the same.
